6	The USGS contract is up for renewal. MSWCD funds USGS to maintain two stream gages Abiqua Creek at Silverton and Butte Creek at Monitor. The contract is for 2023 and is due signed by MSWCD by October 1, 2022.	Approve to renew for 2023 the USGS Contract for \$47,600
8a	The Urban Conservationist (UC) position is new to the District. The position is needed to meet the District's mission within urban areas and develop and implement the Districts Backyard Habitat Program By having an UC on staff we will be able to better serve our urban communities and work with other urban and city partners such as the City of Salem, Keizer, etc.	Approve the new position
8b	The Programs Assistant (PA) position description (PD) has not been revised since 2015. The District Manager has revised the PA PD to reflect the duties as they are today and updated the position title from Programs Assistant to Grants Coordinator (GC). This agenda item is to notify that the Manager has followed up with the Programs Assistant, revised the position description, and will work with the Programs Assistant to review the revised PD, which will now be known as the Grants Coordinator. The packet includes the PA PD with tracked changes and the revised PA as the GC for review. There are no changes to salary proposed. No action requested.	Follow-up Report
8c	A District employee has waived their health benefit and pays for their own health insurance. This discussion regards considering cash compensation to that employee in lieu of the health benefit payment by the District. For this fiscal year the District covers an employee (only-no dependents) for health insurance at a rate of \$697.55 per month. Although the District has no obligation to compensate an employee when they waive a benefit, this is case specific, and it is recommended by the Admin Committee to provide some compensation for the waived health benefit.
