### Potential Environmental Education Partner Funding Stream

Let's consider developing a process for offering capacity funding for environmental/natural resource-focused education groups/organizations in Marion County. This would be similar to providing capacity funding for watershed councils working within the geographic boundaries of Marion SWCD, we could offer capacity funding for organizations that provide natural resources education within the geographic boundaries of Marion SWCD. This would extend our reach and our ability to achieve our mission. Examples of Organizations: Straub Outdoors, Salem Environmental Education, Native Plant Society, 4-H and FFA clubs, Oregon Ag Fest, etc.

Do we, the Ed Committee, recommend developing a process to provide annual capacity funding for environmental education organizations in Marion County? What is the best way to proceed to ensure what we offer is fair and accessible to all environmental education organizations serving Marion County?

Discussion: Can't find a special line item for Straub, it is true though we gave them \$10,000 a year, they would come and report their activities to the board so they would feel comfortable. Jenny Ammon spoke to Catherine and told her, that with the pandemic, Darin talked to Catherine...Darin's point: we haven't been spending that much money, they didn't come and ask for money this year, maybe we could give Straub more this one time, make sure we are fair with other groups, help Straub out extra this year, and work on ideas for how we could help other groups also moving forward. Board is on board with giving additional money this year. We have been working with Straub for over 15 years.

This discussion encompasses two things-1) funds for Straub and 2) setting up a process for funding environmental education organizations. We need to have clear criteria on what organizations would qualify. Some organizations do just a little bit, others do primarily environmental stuff. If environmental concerns are tangential to their main mission, then Scott would be reticent.

1) FUNDS FOR STRAUB - Do we want to offer Straub additional funding this year or just the regular \$10,000? Scott supports giving funds to Straub, so does Darin, Mark suggests giving funding for 2 years, they give a report, then we give them funding for another 2 years - Becky would like to give the funding to Straub now, and set up a framework, including a paid executive director and

Straub would receive \$20,000 (a 1-year higher amount), then come back and go through the new process. Recommend a range of \$10,000-\$20,000 to the board. Mark would be in favor of giving \$20,000 right now to make up for not receiving funds last year. But in future, they would be applying for \$10,000 per year. Recommend to board: Offer Straub Outdoors \$20,000 this year for this year and last year. (Darin moves, Mark seconds) In favor: HK, MF, DO; against: SW – feels more comfortable with \$10,000.

2) SETTING UP A PROCESS TO FUND ENVIRONMENTAL EDUCATION ORGANIZATIONS Brenda – we don't have specific line items for this. We need to set up administrative and accountability processes for these funds. Could we follow the same process being set up for watershed councils, and we set up our own criteria for environmental education? Watershed councils also do environmental education. Mark and Darin think it sounds reasonable to report this conversation to the board. Propose concept to board, get yea or nay, then instruct the committee to develop a framework. For the framework, can we offer 3-4 years of support at a time? Discuss with the board that the education committee thinks it is a good idea to develop a framework for providing funding support for organizations involved in environmental education -

### **Streamlined Salmon Watch Funding Assistance**

Each year, Marion SWCD coordinates Salmon Watch field trips for students in Marion County. We offer funding to cover buses and subs for these trips. Currently, we require teachers to use the same process for Salmon Watch subs and buses that we use for all other CLEAR grants. Streamlining the process will be more efficient for teachers and ourselves. Teachers I have spoken to are in favor of a simplified process. The Program Committee is going through a similar process for certain kinds of LAP grants.
