#### Proposed Cover Crop Rate Increase May, 2024

**Proposal:** Increase the rates of the Cover Crop Assistance Program to follow the chart provided:

Traditional Cover Crops	No-till	Conventional Tillage Drilled	Broadcast with light or minimum tillage
Base Payment	\$ 55/acre	\$ 45/acre	\$ 33/acre
Early planting incentive add:	\$ 10/acre	\$ 10/acre	\$ 10/acre
Planted with multi- species mix add:	\$ 10/acre	\$10/acre	\$ 10/acre
Max Payment Amount	\$ 75/acre	\$ 65/acre	\$ 53/acre

#### Rationale:

- Our current rates are below NRCS cost scenario and other similar programs (see charts below).
- The chart reflects 50% cost share based on NRCS Cost Scenarios.
- Current rates are below the rates offered in the pilot year 2019-2020 despite a heavy increase in costs.
- If an applicant chose the route of a CAG, they would be able to receive a higher payment rate for the same practice which would also add to our staff workload.
