1	Call to order at 11:00 am. Peggy Hart added discussion of CLEAR grant application limits to end of committee meeting.	
2	No public comment.	
3	Darin Olson moves to approve the minutes as submitted. Mark Fields seconded. (Unan: 4:0)	Motion: Olson; Second: Fields. All in favor. (Unan: 4:0) Minutes approved.
4-7	Darin Olson moved that we approve all partner grants, Mark Fields seconded. Susan Oritz asked for clarification on Wisdom of Elderberry: Olson had marked that one as "Defer to staff." Olson is fine to move them all forward. Peggy Hart would like discussion on all four partner grants with educational aspects. Discussion: A) Institute for Applied Ecology: prairie enhancement- taking place at Champoeg, in cooperation with State Parks and The Confederated Tribes of Grand Ronde. Project has a large volunteer aspect doing work on the ground. Avg. Rank: 46 out of 50. B) 2 <sup>nd</sup> application – Native American Climate Adaptation Partnership – has lots of partners. Has education and outreach and project implementation. Applicant plans to continue training of underrepresented youth, using Traditional Ecological Knowledge (TEK), hands-on projects. AVG. Rank: 49 if don't include "defer." Susan Ortiz reminded the committee that if an application receives 3 or more "defer" or "do not fund" marks, it is automatically denied. At Darin Olson's suggestion, Ortiz will remove his "defer/0" score from the total. C) 3 <sup>rd</sup> project – Pudding River Native Plant Outreach Plot. Pudding River Watershed Council will work with OSU Experiment Station in Aurora on their native plant nursery. The purpose is to grow native plants for projects mainly	All in favor of recommending these four Partner Grants for funding in full to the Board. Motion: Olson; Second: Fields. (Unan: 4:0)

within Marion SWCD's district. The plot is not located within District boundaries, although the majority of people it will benefit are in Marion District. AVG. Rank: 45.3. D) Westminster habitat improvement – located within City of Salem, remove invasives, add natives, mostly done by volunteers. Overall, their requested amount is much lower than what we usually see for these types of projects, but this is their first grant. AVG Rank: 44.5.

All in favor of recommending these four Partner Grants for funding in full to the Board. None opposed.

Olson commented that it is confusing to have multiple recommendations from the different committees. It would be good to figure out how to have the Partner Grants reviewed by one committee. Those will be brought forward at May meeting hopefully. The next Partner Grant cycle will open mid-June and close August 15. If needed, Susan Ortiz will make process improvement recommendations to the board for their consideration.

Discussion of the \$2000 limit per CLEAR grant application. According to Olson, many years ago, the committee had the authority to give out money themselves, the committee was limited to \$2000 that they could give out without board approval. At the time, that covered what the needs were. There is no longer a need to keep the \$2000 limit. Darin suggested that we change it to match the other committees' limits. We can talk about and do whatever we want to do. Why limit educators more than CAG applicants? Ortiz provided this information: Outside of Salmon Watch, we received 6 CLEAR grant applications last year - all were \$2000 or more. At the April meeting we can look at Salmon Watch in particular to see what we want to offer. Olson moved that we change the per application limit from \$2,000 to \$5,000, and then amended the motion to: Change the per CLEAR grant application limit from \$2,000 to \$5,000, and for people with three successful years of applications, they can apply for up to \$7,500 per application. All in favor. Meeting adjourned at 11:39 am
